

COVID-19 WAIVER OF LIABILITY AND INDEMNIFICATION

1. I agree that I am personally responsible for my safety and actions of myself and all guests whom I have invited to attend a party (the "FAIRYTALE PARTY") initiated through the services provided by Amazing Fairytale Parties LLC and/or website platform <https://amazingfairytaleparties.com> (collectively "AFP") and third party independent contractor party performers ("Party Performers"). I shall comply with all applicable local, state, and federal guidelines in effect governing personal conduct due to the SARS-CoV-2 virus and COVID-19 illness and shall cause all my invited guests to so comply. I recognize that I and my invited guests attending said FAIRYTALE PARTY are at higher risk of contracting COVID-19 due to such attendance. With full awareness and appreciation of the risks involved, I, and on behalf and of any of my minor child/children, my family, spouse, estate, heirs, executors, administrators, assigns, and personal representatives, hereby forever release, waive, discharge, and covenant not to sue AFP, its managers, members, officers, agents, servants, independent contractor Party Performers, affiliates, employees, successors, and assigns (collectively the "Released Parties") from any and all liability, claims, demands, actions, and causes of action whatsoever, directly or indirectly arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or any of my invited guests related to COVID-19 whether caused by the negligence of the Released Parties, any third-parties guests attending said FAIRYTALE PARTY, or otherwise, while participating in any activity at said FAIRYTALE PARTY.

2. I agree to indemnify, defend, and hold harmless the Released Parties from and against any and all costs, expenses, damages, claims, lawsuits, judgments, losses, and/or liabilities (including attorney fees) arising either directly or indirectly from or related to any and all claims made by or against any of the Released Parties due to bodily injury, death, loss of use, monetary loss, or any other injury from or related to my and any of my invited guest's attendance and participation at said FAIRYTALE PARTY whether caused by the negligence of the Released Parties or otherwise specifically related to COVID-19.

By signing below I acknowledge and represent that I have read the this COVID-19 WAIVER OF LIABILITY AND INDEMNIFICATION ("Covid-19 Waiver"), understand it and signed it voluntarily as my own free act and deed, including without limitation the release of liability and indemnification requirements contained herein; I am sufficiently informed about the risks involved in attending the FAIRYTALE PARTY to decide whether to sign this document; no oral representations, statements, or inducements, apart from this document or those contained in the Terms of Service of the above mentioned website, , have been made; I am at least eighteen (18) years of age and fully competent; have the full power and authority to execute this Covid-19 Waiver and I execute this document for full, adequate, and complete consideration fully intending to be bound by the same. Besides myself I am signing this Covid-19 Waiver on behalf of any minor child or children of mine attending said FAIRYTALE PARTY. I agree that this Covid-19 Waiver shall be governed by and construed in accordance with Oregon law, and that if any of the provisions hereof are found to be unenforceable, the remainder shall be enforced as fully as possible and the unenforceable provision(s) shall be deemed modified to the limited extent required to permit enforcement of the waiver of liability and indemnification as a whole.
